The CLW-SLVU-P is a Crestron® wall mount slave dimmer designed for use with CLW dimmers and switches. Multipoint dimming is enabled using CLW dimmers or switches and up to nine slave dimmers each. Multipoint dimming is similar to conventional 3-way or 4-way switching, allowing dimming control of a single load from multiple locations in the room.

NOTE: The CLW-SLVU-P cannot be used to control a load directly, but must be used in conjunction with a CLW-SWEX-P, CLW-DIMEX-P or CLW-DELVEX-P.

- Wiring: Use copper wire only. For supply connections, use wire rated for at least 75° C.
- · Electrical Boxes: Devices mount in standard electrical boxes. For easy installation, Crestron recommends using 3 1/2 in (89 mm) deep electrical boxes. Several devices can be installed in one electrical box (multigang). This requires derating of the dimming device. For a smooth appearance, one-piece multigang faceplates (not supplied) can be installed
- Spacing: If mounting one device above another, leave at least 4 1/2 in (115 mm) vertical space between them.
- Neutral connection required for CLW-SLVU-P LED to function.


INSTALLATION

WARNING: Turn off power at the circuit breaker. Installing with power on can result in serious personal injury and damage to the device.

The following describes the installation of a CLW-SLVU-P dimmer.


- 1. Turn power off at the circuit breaker
- 2. The diagrams to the right illustrate typical wiring configurations for the CLW-SLVU-P. Select the appropriate configuration and connect the necessary wires.


NOTE: Refer to the following diagram when making connections to the device.





- 3. Push all power wires back into the electrical box and fasten the device to the electrical box with the provided screws.
- 4. Attach decorative faceplate.
- 5. Ensure all buttons actuate without sticking.
- 6. Restore power at the circuit breaker.









Changing Button Assemblies

The button assembly can be removed and replaced with other button assemblies. To change the button assembly:


1. As shown in the following diagram, remove the button assembly by squeezing the sides of the bezel near the bezel snaps.




Remove button(s) from the front of the button assembly as shown in the following diagram.



3. Insert new buttons through the front of the bezel and snap into place as shown in the following diagram. Ensure that the LED strip is on the left side.



4. Attach button assembly to the device as shown in the following diagram. Ensure that LED strip is on the left side.




OPERATION

Basic Operation

NOTE: The device may be warm to the touch during operation. This is normal.

The CLW-SLVU-P is shipped with a rocker switch already installed. In this configuration, the unit functions as shown below.

The specific functions of the slave device depend on the master device at the other end. If the master is a CLW-DELVEX-P or CLW-DIMEX-P, then the button function is the same as a CLW-DIMEX-P with a rocker; if a switch is installed, the slave function is the same as a switch with a rocker button.




Default Button Functions


The figures below illustrate the default functions available for each physical button configuration and tap/hold actuation sequence.

NOTE: Delayed off can be added via control system programming.

TROUBLESHOOTING

The table after this paragraph provides corrective action for possible trouble situations. This troubleshooting applies to multi-way installations where one or more slave device (CLW-SLVU-P) is connected to a master (CLW-DIMEX-P, CLW-SWEX-P or CLW-DELVEX-P). If further assistance is required, please contact a Crestron customer service representative.

	Existing 3- or 4-way switch still connected.	Replace 3- or 4-way switches with CLW-SLVU-230-P. Replace 3-way switch connected to load with CLW-DIM or CLW-SW.	
Master dimmer works but neither button on slave works.	Wiring issue.	Check connections on all slave units and on master dimmer.	
	Wiring issue at master dimmer, LOAD and HOT reversed.	Check connections at master dimmer.	
	Existing 3- or 4-way switch still connected.	Replace 3- or 4-way switches with CLW-SLVU-230-P. Replace 3-way switch connected to load with CLW-DIM or CLW-SW.	
Master dimmer works but only the bottom button on slave works.	Master dimmer / slave is not connected at the load side of the multi-way circuit.	Ensure master dimmer is connected at the load side of the multi-way chain connects directly to the lighting fixture.	
Pressing buttons on slave makes master dimmer perform the wrong action.	Wiring at slave is incorrect, HOT and REM swapped.	Ensure that HOT , NEU and REM on slave are connected correctly.	
Slave LED does not function (i.e., stays off).	No neutral connection at slave.	Connect neutral to slave.

Return and Warranty Policies

Merchandise Returns / Repair Service

- No merchandise may be returned for credit, exchange or service without prior authorization from Crestron. To obtain warranty service for Crestron products, contact an authorized Crestron dealer. Only authorized Crestron dealers may contact the factory and request an RMA (Return Merchandise Authorization) number. Enclose a note specifying the nature of the problem, name and phone number of contact person, RMA number and return address.
- 2. Products may be returned for credit, exchange or service with a Crestron Return Merchandise Authorization (RMA) number. Authorized returns must be shipped freight prepaid to Crestron, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. Crestron reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- Return freight charges following repair of items under warranty shall be paid by Crestron, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

Crestron Limited Warranty
