# Wall Plate DigitalMedia™ CAT Transmitter: DM-TX1-1G

### Introduction

Part of Crestron's DM<sup>®</sup> product line, the DM-TX1-1G is a DigitalMedia<sup>TM</sup> CAT transmitter that installs in a single-gang wall box or floor box. It provides one HDMI<sup>®</sup> input for a computer or high-definition AV source as part of a complete DigitalMedia system.

#### **Features and Functions**

- DigitalMedia transmitter and HDMI interface
- DM CAT output supports up to 175 feet (53 meters) cable length<sup>1</sup>
- Compact 1-gang wall mount design
- Available colors include black or white
- Provides HDMI digital video/audio input at any location
- Also supports DVI and DisplayPort Multimode sources<sup>2</sup>
- Affords single-wire connection to a DM-MD switcher (sold separately)
- Supports 3D HDTV signals

#### DigitalMedia

Crestron® has developed DigitalMedia, the first complete HD AV distribution system that takes HDMI to a higher level, and allows virtually any mix of AV sources to be distributed throughout the home, office, school, or virtually any other facility.

DigitalMedia distributes uncompressed digital video and audio signals several hundred feet using DM cable. DigitalMedia manages all of the different signals and devices, matching each source's output to the capabilities of the selected display(s) without using scaling or compression. Every signal is preserved in its native video resolution and audio format, ensuring a pure, lossless signal path throughout.

#### Multimedia Computer/AV Interface

Via its HDMI input, the DM-TX1-1G handles 1080p60 HDTV with HDCP and multi-channel HD lossless audio. The HDMI input can also handle WUXGA computer resolutions, and supports DVI and DisplayPort Multimode signals using an appropriate adapter or interface cable.<sup>2</sup>

The DM-TX1-1G connects to the DM CAT input of a DM-MD series switcher, carrying a multimedia computer or AV signal up to 175 feet (53 meters)<sup>1</sup> away. Multiple DM-TX1-1Gs may be installed to enable the distribution of several sources at different locations to feed multiple displays throughout any room or larger facility.

#### Simple Wall Mount Design

The DM-TX1-1G is designed to be wall mounted using a standard electrical box or plaster ring, or attached to a rack rail in the back of an equipment cabinet. The DM cable is terminated to the rear of the transmitter using screw terminals.



# **Applications**

**NOTE:** As shown in the diagram below, the DM-TX1-1G must connect directly to a DM switcher. The DM-TX1-1G cannot be used in a standalone configuration, that is, used without connection to a DM switcher.





- 6. A grounding lead is provided for connection to earth ground (building steel). This ground connection is recommended to provide a common ground reference for signals provided to the DM-TX-1G, and to reduce the incidence of possible damage to the unit from static discharge.

# **Network Wiring**

When wiring the DM network, consider the following:

**NOTE:** DMNet wiring and Cresnet<sup>®</sup> wiring are not compatible.

- Use Crestron Certified Wire.
- Use Crestron power supplies for Crestron equipment.
- Provide sufficient power to the system.
- For DigitalMedia CAT wiring, use DM-CBL DigitalMedia Cable. Refer to the latest version of the Crestron DigitalMedia Design Guide (Doc. 4789) for complete wiring guidelines.

**CAUTION:** Insufficient power can lead to unpredictable results or damage to the equipment. Please use the Crestron Power Calculator to help calculate how much power is needed for the system (<a href="www.crestron.com/calculators">www.crestron.com/calculators</a>).

# Configuration

#### Cable Selection

The DM-TX1-1G must be configured to accept the type of cable used during installation. DIP switches are provided on the unit to indicate the installed cable type. Refer to the table below for DIP switch settings.

#### Master/Slave Mode

The DIP switches on the DM-TX1-1G can be used to switch the unit into DMNet *Master* mode or DMNet *Slave* mode. Selecting the appropriate DMNet mode will allow the unit to receive firmware updates from other Crestron devices.

- In DMNet *Master* mode, a DM-MD8X8 or other DM switcher (sold separately) equipped with a DMC-CAT card can be used to update the firmware.
- In DMNet *Slave* mode, a control system such as the PRO2 can be used to update the firmware.

Refer to the following table below to set the *Master/Slave* mode.

#### Installation

To prevent overheating, do not operate this product in an area that exceeds the environmental temperature range listed in the table of specifications.

To install the DM-TX1-1G, the following tools and accessories are required for installation:

- DM-CBL DigitalMedia Cable (not supplied.) Refer to "Network Wiring" on page 13.
- Phillips screwdriver (not supplied)
- Adjustable wrench (not supplied)
- Miniature flat head screwdriver (not supplied)
- Two #06-32 x 3/4" oval head slotted screws (2009684, included)
- Decorative-style faceplate (not supplied)
- Insert (4510566 or 4512253, included)


The DM-TX1-1G can be installed in either a 1-gang electrical box or rack mounted.

Installing in a 1-Gang Box

An extra-deep box is recommended (2-1/2 inch (64 mm) deep minimum). It is assumed that the required cable has been fed through an installed 1-gang electrical box (not supplied), and wiring has been verified. Use the following procedure to install the DM-TX1-1G.


- 1. Confirm that DMNet system power is OFF.
- 2. Strip 3 inches (77 mm) of the DigitalMedia Cable to expose the three inner cables.
- 3. Strip the outer jacket of the blue "D" cable 1 3/4 inch (45 mm) from end. Gather and twist the wire braid. Refer to the illustration at the top of the next page.

- 4. Trim foil shield to 1/2 inch (13 mm).
- 5. Remove the white neoprene sheath and separate the twisted pairs to expose the spline. Cut the spline so that it is near flush with the foil shield as shown in the following diagram. Return twisted pairs to original position.


#### "D" Cable (Cutting the Spline)



6. Neatly wrap the twisted braid around the foil shield as shown in the following diagram. Only the silver side of foil shield is conductive.

**NOTE:** Braid should wind neatly around foil shield. Loose braid may cause shorts.

#### "D" Cable (Wrapping the Twisted Braid)




7. Strip the insulation from the ends of each wire, exposing approximately 3/16 inch (5 mm) of bare copper.

**NOTE:** Do not allow the twisted pairs to untwist for more than 1/2 inch (13 mm).

**NOTE:** Maintain equal wire lengths within 1/8 inch (3 mm).

8. Using an adjustable wrench, clamp the prepared cable to the unit as shown in the following diagram.


**NOTE:** Twisted braid and foil shield must be in full contact with inside of clamp.



#### Clamping the Cable to the Unit


- 9. Repeat steps 3 through 8 for the yellow "M" cable.
- 10. Using a miniature flat head screwdriver (not supplied), make the connections as specified, using the labels on the unit as a guide.
  - a. Insert the twisted pairs of the gray DMNet cable into the **G B A 24** terminal block and tighten each screw base. Refer to footnote 4 on page 12 for details.

#### GBA 24 Terminal Block




b. Insert the twisted pairs of the blue "D" cable into the **D** terminal block and tighten each screw base. Refer to footnote 1 on page 11 for details.

c. Insert the twisted pairs of the yellow "M" cable into the **M** terminal block and tighten each screw base. Refer to footnote 1 on page 11 for details.

#### M Terminal Block




- 11. Remove the pre-cut insulation from the grounding wire and connect it to the electrical box or a ground wire in the electrical box (the electrical box must be earth grounded).
- 12. Attach the unit to the electrical box using the two included #06-32 x 3/4" oval head slotted screws as shown in the illustration on the following page.

**CAUTION:** Excess wire pinched between the unit and electrical box could cause a short. Make sure that all excess wire is completely inside the electrical box and not between the box and the side of the unit.

- 13. Attach an appropriate decorative-style faceplate (not supplied).
- 14. Remove the backing from the tape on the back of the insert. Affix the insert plate into the proper opening in the wallplate.

#### DM-TX1-1G in 1-Gang Box (Exploded View)




Rack Mounting

The DM-TX1-1G can be mounted in a rack with other equipment using the two mounting holes on either corner of the unit. It is assumed that the required cable has been installed and wiring has been verified.

- 1. Follow steps 1 through 10 in the procedure outlined for installing the DM-TX1-1G in a 1-gang box, which begins on page 15.
- 2. Attach the unit to the rack using the rack mount screws (not supplied) as shown in the following diagram.
- 3. Remove the pre-cut insulation from the grounding wire and connect it to an appropriate earth ground.

4. Remove the backing from the tape on the back of the insert. Affix the insert plate onto the unit as shown. Refer to the following diagram.

**WARNING:** To prevent bodily injury when mounting or servicing this unit in a rack, take special precautions to ensure that the system remains stable. The following guidelines are provided to ensure your safety:

- When mounting this unit in a partially filled rack, load the rack from the bottom to the top with the heaviest component at the bottom of the rack.
- If the rack is provided with stabilizing devices, install the stabilizers before mounting or servicing the unit in the rack.



# **Check Network Wiring**

Use the Right Wire

In order to ensure optimum performance over the full range of your installation topology, Crestron Certified Wire and only Crestron Certified Wire may be used. Failure to do so may incur additional charges if support is required to identify performance deficiencies because of using improper wire.

Calculate Power

**CAUTION:** Use only Crestron power supplies for Crestron equipment. Failure to do so could cause equipment damage or void the Crestron warranty.

**CAUTION:** Provide sufficient power to the system. Insufficient power can lead to unpredictable results or damage to the equipment. The **EIG** connector on the DM switcher is used to bring in external power. Additional power is rarely required as switchers provide enough power for their maximum configuration of room controllers and repeaters. Please use the DMNet Power Calculator to help calculate how much power is needed for the system (<a href="www.crestron.com/calculators">www.crestron.com/calculators</a>).

**NOTE:** All Crestron certified DMNet wiring must consist of two twisted pairs. One twisted pair is the +24V conductor and the GND conductor and the other twisted pair is the A conductor and the B conductor.

- 3. Return freight charges following repair of items under warranty shall be paid by CRESTRON, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.
