

The FTA-PWR-261 occupies three connector plate slots in a 600 Series FlipTop. Use the following procedure to install the FTA-PWR-261.

- 1. Prepare the FlipTop by removing the six screws that secure three adjacent, blank connector plates. These can be the three connector plates on the left or the three connector plates on the right.
- 2. Remove the three blank connector plates.
- 3. Place the FTA-PWR-261 in position and secure it with four of the six 06-32 x 1/4" screws from step 1. For convenience, the FTA-PWR-261 ships with four replacement screws (2007215).
