DigitalMedia™ CAT & Fiber Transmitters 100: DM-TX-100/-F

Introduction

The DM-TX-100 is a DigitalMedia™ CAT transmitter and the DM-TX-100-F is a DM Fiber transmitter. Part of the Crestron® DM® product line, they provide a single HDMI® input for a computer or high definition AV source. They are ideal for use at a lectern, conference table, wall plate or any remote location in a boardroom, classroom or residence to route an HDMI signal to a display or switcher many feet away.

For simplicity within this guide, the term "DM-TX-100/-F" is used except where noted.

DigitalMedia

As the leader in HDMI and control system technologies, Crestron[®] has developed DigitalMedia, the first complete HD AV distribution system that takes HDMI to a higher level and allows virtually any mix of AV sources to be distributed throughout the home, office, school or virtually any other facility.

DigitalMedia distributes uncompressed digital video and audio signals up to 450 feet (137 meters) using DM cable² for the DM-TX-100 and up to 1000 feet (300 meters) using multimode fiber optic cable³ for the DM-TX-100-F. DigitalMedia thoughtfully manages all of the different signals and devices, matching each source's output to the capabilities of the selected display(s) without using scaling or compression. Every signal is preserved in its native video resolution and audio format, ensuring a pure, lossless signal path throughout.

Multimedia Computer/AV Interface

Via its HDMI input, the DM-TX-100/-F supports HDMI with Deep Color and HDCP, handling WUXGA computer resolutions and 1080p60 HDTV with multi-channel HD lossless audio. The HDMI input can also handle DVI and DisplayPort Multimode signals using an appropriate adapter or dongle. Crestron offers a complete range of professional AV interface cables and wall plates to complement the DM-TX-100/-F for a total custom installation solution.

NOTE: HDMI requires an appropriate adapter or interface cable to accommodate a DVI or DisplayPort Multimode signal. CBL-HD-DVI and CBL-DP-HD interface cables sold separately.

Used with a single DM-RMC-100 Room Controller (for the DM-TX-100) or a DM-RMC-100-F (for the DM-TX-100-F) and optional Crestron Control System (all sold separately), the DM-TX-100/-F affords a very simple solution for extending a multimedia computer or AV signal to a single display up to 450 feet (137 meters) away² for the DM-TX-100 and up to 1000 feet (300 meters) away³ for the DM-TX-100-F. As part of a larger system using a DM series switcher (sold separately), multiple DM-TX-100/-Fs may be installed to enable distribution of several sources at different locations to feed multiple displays throughout any room or larger facility.

Keyboard/Mouse Extender

The DM-TX-100/-F also functions as a keyboard/mouse extender, allowing the computer or other USB HID (Human Interface Device) compliant host device connected to the DM-TX-100/-F to be controlled by a keyboard and mouse connected at the display location.

HID devices include mice, keyboards, trackballs and composite devices (e.g. combination keyboard/trackball devices). These devices do not require driver installation on most common operating systems (Windows XP/Vista and Mac OS).

EDID Format Management (DM-TX-100 only)

The DM-TX-100 allows for management of the EDID (Extended Display Identification Data) information that passes between the display devices and input sources in the system. Using Crestron Toolbox™ software, the format and resolution capabilities of each device can be assessed and managed through the DM-TX-100, ensuring reliable operation by instructing sources to output only the resolutions and formats that can be handled by the displays and system wiring.

Embedded Device Control

The primary objective of every Crestron system is to enable precisely the control desired for a seamless user experience. The DM-TX-100/-F includes built-in IR and Ethernet control ports to allow programmable control of the devices connected to it. The DM-TX-100/-F also provides an alternative to conventional control methods by harnessing the CEC (Consumer Electronics Control) signal embedded in HDMI. Through its connection to the control system, the DM-TX-100/-F provides a gateway for controlling the connected source device right through the HDMI connection, potentially eliminating the need for any dedicated control wires or IR probes.

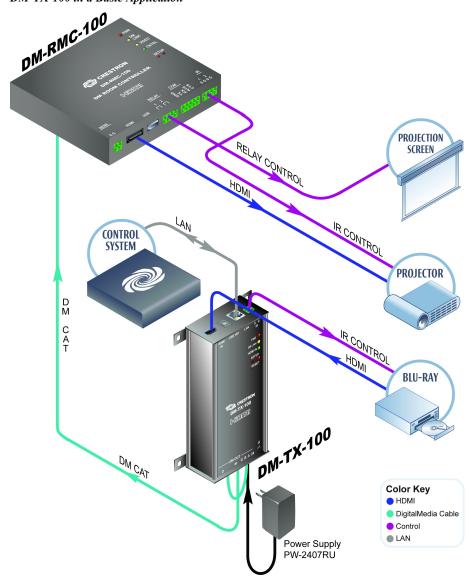
Compact and Versatile

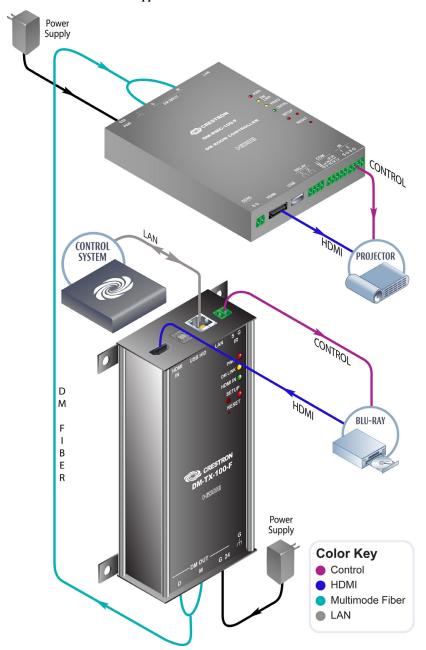
The DM-TX-100/-F is designed to be mounted on a flat surface or attached to a rack rail in the back of an equipment cabinet. It may also be used portably for connection to a DM wall plate input (MP-WP185 sold separately). It is compact enough to fit discreetly inside a presentation lectern or beneath a table. An array of indicators on the front of the DM-TX-100/-F provides for easy setup and troubleshooting, verifying the status of connections and signal activity at a glance. Advanced configuration is enabled through Crestron Toolbox software.

No **LAN** connection is required for these devices to transmit HDMI and USB in a point-to-point configuration. If you wish to use the control ports (IR, RS-232, Relay, Sense) from a control system, you can connect either **LAN** port (on the DM-TX-100/-F) to the control system's network. Both devices will be connected because Ethernet is embedded inside DM. You may also use the other **LAN** connection to provide Ethernet connectivity to a remote device.

For DM CAT (e.g. DM-TX-100) you only have to apply power to one and the other will receive it through the DMNet cable. For DM fiber (e.g. DM-TX-100-F), each end has a local power supply. With the DM-TX-100-F, all you need is the fiber connection.

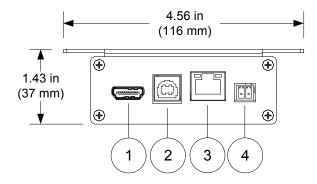

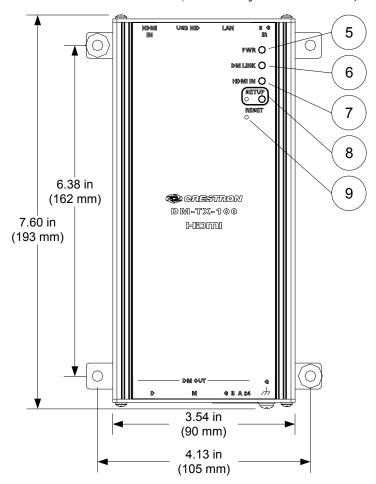
DM-TX-100/-F Physical View (Top Ports of DM-TX-100 Shown)



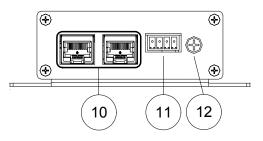
DM-TX-100/-F Overall Dimensions (Top View)



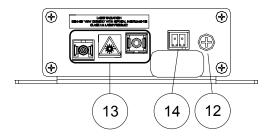
DM-TX-100/-F Overall Dimensions (Front View of DM-TX-100 Shown)

Setup

Network Wiring

When wiring the DM network, consider the following:

NOTE: DMNet wiring and Cresnet® wiring are not compatible.

- Use Crestron Certified Wire.
- Use Crestron power supplies for Crestron equipment.
- Provide sufficient power to the system.

CAUTION: Insufficient power can lead to unpredictable results or damage to the equipment. Use the Crestron Power Calculator to help calculate how much power is needed for the system (www.crestron.com/calculators).

- For DigitalMedia CAT wiring, use DM-CBL DigitalMedia Cable. Up to two DM Repeaters (model DM-DR, sold separately) may be required. Refer to the latest revision of the Crestron DigitalMedia Design Guide (Doc. 4789) for complete wiring guidelines.
- For DigitalMedia Fiber wiring, use CresFiber or other quality simplex multimode fiber optic cable. The maximum supported cable length is 1000 feet (~300 meters). Refer to the latest version of the Crestron DigitalMedia Design Guide (Doc. 4789) for complete wiring guidelines.

The DM-TX-100/-F also uses high-speed Ethernet for communications between the device and a control system, computer, media server and other IP-based devices. Identity Code

NOTE: In the SIMPLTM Windows program, the IP ID of the DM-TX-100/-F is assigned automatically and does not require additional programming when the DM-TX-100/-F is dropped onto an output card of a DM switcher. Use the information below when the DM-TX-100/-F is dropped directly into an Ethernet slot on the control system in SIMPL Windows without a DM switcher.

The IP ID is set within the DM-TX-100/-F IP table using Crestron Toolbox. For information on setting an IP table, refer to the Crestron Toolbox help file. The IP IDs of multiple DM-TX-100/-F devices in the same system must be unique.

When setting the IP ID, consider the following:

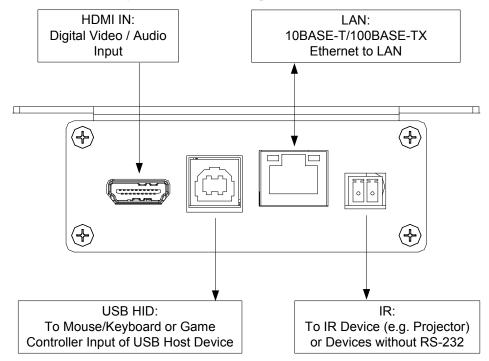
- The IP ID of each unit must match an IP ID specified in the SIMPL Windows program.
- Each device using IP to communicate with a control system must have a unique IP ID.

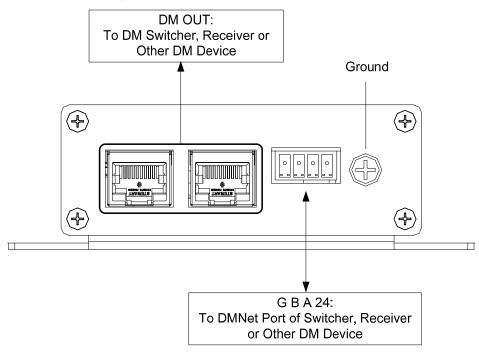

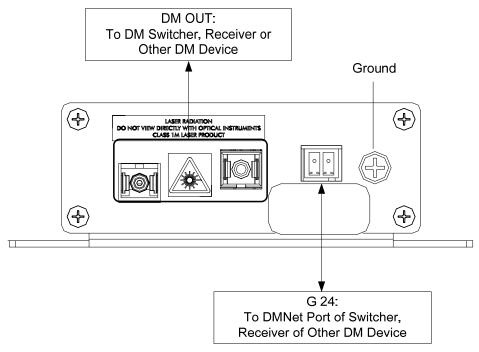

NOTE: Ensure the unit is properly grounded by connecting the chassis ground lug to an earth ground (building steel).

NOTE: To prevent overheating, do not operate this product in an area that exceeds the environmental temperature range listed in the table of specifications.

NOTE: For optimum performance with the DM-TX-100, use DM-CBL DigitalMedia cable. For optimum performance with the DM-TX-100-F, Crestron recommends using CresFiber or other quality duplex multimode fiber optic cable.

NOTE: Minimum recommended length for DM-CBL DigitalMedia cable is 15 feet (~4.6 meters).

NOTE: When used without a DM switcher, the DM-TX-100/-F can be powered by a PW-2407RU or any Crestron 24 Volt power supply. Power supply included with DM-TX-100-F, not included with DM-TX-100.

For the minimum recommended software versions, visit the Version Tracker page of the Crestron Web site (www.crestron.com/versiontracker).

Programming with SIMPL Windows

SIMPL Windows is Crestron's premier software for programming Crestron control systems. It is organized into two separate but equally important "Managers": Configuration and Program.

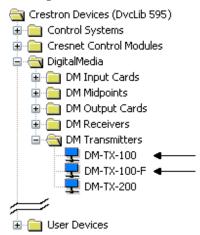
Configuration Manager

Configuration Manager is the view where programmers "build" a Crestron control system by selecting hardware from the *Device Library*.

In the examples shown on the following pages, the DM-TX-100 and DM-TX-100-F are being used in a DigitalMedia system with a DM-MD8X8 Switcher, equipped with a DMC-CAT input card (for the DM-TX-100) or a DMC-F input card (for the DM-TX-100-F). For details, refer to the latest version of the DigitalMedia Switchers Operations Guide (Doc. 6755).

1. Locate the DM-TX-100/-F in the DigitalMedia | DM Transmitters folder of the *Device Library*.

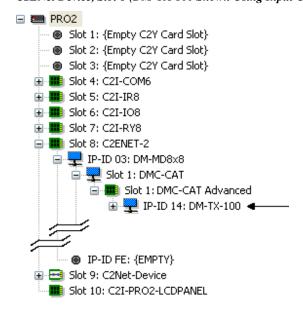
Locating the DM-TX-100 and DM-TX-100-F in the Device Library



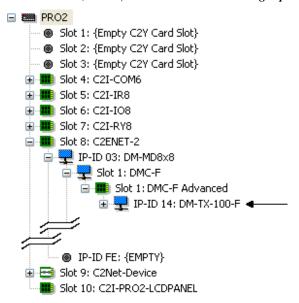
- 2. Drag the DM-TX-100 or DM-TX-100-F from the *Device Library* and drop it into either of the following in the *System Views*:
 - A compatible input card of a DM switcher
 - Directly to a card in the Ethernet slot of the control system (used without a DM switcher)

The system tree of the control system displays the DM-TX-100 or DM-TX-100-F in the appropriate slot with a default IP ID as shown in the following examples. In the first example, the DM-TX-100 is used with the DMC-CAT input card in a DM-MD8X8 switcher. The DM-TX-100-F is also shown with the DMC-F input card in a DM-MD8X8 switcher.

C2ENet Device, Slot 8 (DM-TX-100 Shown Using Input Card in DM Switcher)

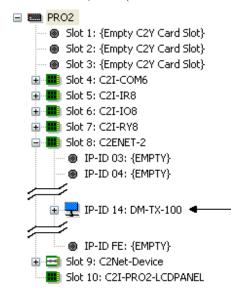


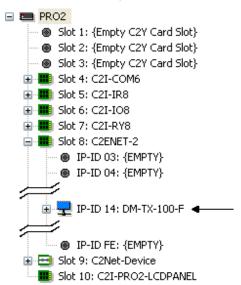
C2ENet Device, Slot 8 (DM-TX-100-F Shown Using Input Card in DM Switcher)



In the second example, the DM-TX-100/-F can be dragged directly to a card such as the C2ENET-2, in the Ethernet slot of the control system, when it is to be used without a DM switcher.

C2ENet Device, Slot 8 (DM-TX-100 Shown Using Ethernet Slot on Control System)

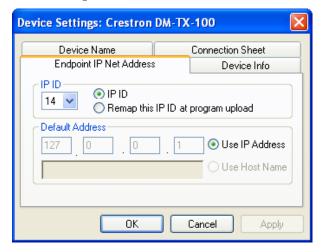




C2ENet Device, Slot 8 (DM-TX-100-F Shown Using Ethernet Slot on Control System)

- 3. If additional DM-TX-100/-F devices are to be added, repeat step 2 for each device. Each DM-TX-100/-F device is assigned a different IP ID.
- 4. If necessary, double click a device to open the "Device Settings" window and change the IP ID, as shown in the following figure (DM-TX-100 shown).

NOTE: The ID code specified in the SIMPL Windows program must match the IP ID of each unit. Refer to "Identity Code" on page 14.

Program Manager

Program Manager is the view where programmers "program" a Crestron control system by assigning signals to symbols.

The symbol can be viewed by double clicking on the icon or dragging it into *Detail View*. Each signal in the symbol is described in the SIMPL Windows help file (F1).

Uploading and Upgrading

Crestron recommends using the latest programming software and that each device contains the latest firmware to take advantage of the most recently released features. However, before attempting to upload or upgrade it is necessary to establish communication. Once communication has been established, files (for example, firmware) can be transferred to the control system (and/or device). In addition, the IP table of the device can be configured.

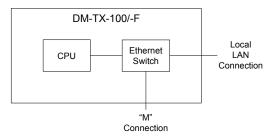
Establishing Communication

Use Crestron Toolbox for communicating with the DM-TX-100/-F; refer to the Crestron Toolbox help file for details.

The DM-TX-100/-F has an internal Ethernet switch that allows communication between the DM-TX-100/-F and a PC running Crestron Toolbox. As shown in the following illustration, the DM-TX-100/-F connects to the PC in either of the following ways:

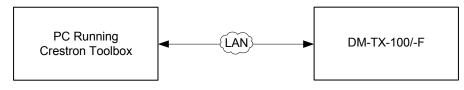
- Locally via the LAN port when the DM-TX-100/-F is used in a standalone configuration (not connected to a DM switcher)
- Remotely via the Ethernet network over the "M" fiber when the DM-TX-100/-F connects to a DM switcher

The DM-TX-100/-F connects to a PC via Ethernet:

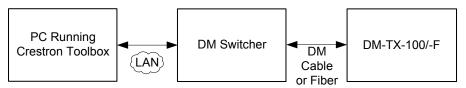
1. Use the Device Discovery Tool in Crestron Toolbox to find the IP address of the DM-TX-100/-F. The tool is available in Toolbox version 1.15.143 or later.

NOTE: When the DM-TX-100/-F is used in a standalone configuration (not used with a DM switcher), DHCP is enabled by default. If desired, a default IP address (192.168.1.244) can be assigned by holding down its **SETUP** button while applying power. This IP address overwrites any previous settings and remains until it is changed manually.

- 2. Use the Address Book in Crestron Toolbox to create an entry for the DM-TX-100/-F using the TCP connection type, and enter the IP address of the DM-TX-100/-F.
- 3. Display the "System Info" window of the DM-TX-100/-F (click the icon); communications are confirmed when the device information is displayed.
- 4. (Optional) If additional changes to TCP/IP settings are desired, do the following:
 - a. Assign an IP address, IP mask, and default router for the DM-TX-100/-F via the Crestron Toolbox (Functions | Ethernet Addressing).
 - b. In Crestron Toolbox, change the Address Book entry for the DM-TX-100/-F so that it uses the IP address assigned in step 4a.
 - c. Display the "System Info" window of the DM-TX-100/-F (click the icon); communications are confirmed when the device information is displayed.

DM-TX-100/-F connects to DigitalMedia switcher via DM network:

- Establish communication between the PC and the DM switcher as described in the latest version of the DigitalMedia Switchers Operations Guide (Doc. 6755).
- 2. Use the Device Discovery Tool in Crestron Toolbox to detect the IP address of the DM-TX-100/-F. The tool is available in Toolbox version 1.15.143 or later.

NOTE: When the DM-TX-100/-F is connected to a DM switcher, the switcher manages the IP configuration of the DM-TX-100/-F and assigns the proper IP address.

- 3. Use the Address Book in Crestron Toolbox to create an entry for the DM-TX-100/-F using the TCP connection type, and enter the IP address of the DM-TX-100/-F.Use the Address Book in Crestron Toolbox to create an entry for the DM-TX-100/-F using the expected communication protocol (Indirect). Select the IP address of the DM-TX-100/-F and the address book entry of the control system that is connected to the DM-TX-100/-F.
- 4. Display the "System Info" window of the DM-TX-100/-F (click the icon); communications are confirmed when the device information is displayed.

Firmware

Firmware files may be distributed from programmers to installers or from Crestron to dealers. Firmware upgrades are available from the Crestron Web site as new features are developed after product releases. For details on upgrading, refer to the Crestron Toolbox help file.

Check the Crestron Web site to find the latest firmware. (New users may be required to register to obtain access to certain areas of the site, including the FTP site.)

To upgrade DM-TX-100/-F firmware:

- 1. Do either of the following.
 - If the DM-TX-100/-F is connected to a DM switcher, use the Device
 Discovery Tool in Crestron Toolbox to find the IP address of the
 switcher. If the DM-TX-100/-F is being used with a DM switcher, use
 the Device Discovery Tool in Crestron Toolbox to find the IP address
 of the switcher. Add the IP address of the switcher to the Address Book
 in Toolbox.

NOTE: When the .puf file is pointed to the DM switcher, all DM devices connected to the switcher, including the DM-TX-100/-F, will be upgraded. When it is pointed to a DM-TX-100/-F in a standalone configuration, only the DM-TX-100/-F will be upgraded.

- If the DM-TX-100/-F is being used in a standalone configuration (not used with a DM switcher), use the Device Discovery Tool to find the IP address of the DM-TX-100/-F. If the DM-TX-100/-F is not being used with a DM switcher (standalone configuration), use the Device Discovery Tool to find the IP address of the DM-TX-100/-F. Add the IP address of the DM-TX-100/-F to the Address Book in Toolbox.
- 2. Download the appropriate .puf file from the Crestron Web site.
- 3. Double-click the .puf file. The Toolbox Address Book opens.
- 4. From the list in the Address Book, select the DM switcher (if the DM-TX-100/-F is being used with a switcher) or select the DM-TX-100/-F (if it is being used in a standalone configuration) and click **OK**.
- 5. From the DM device list, select the item(s) to upgrade using the checkboxes (if they have not already been selected automatically).
- 6. Click Update.
- 7. After the process is complete, click **Recheck** to verify the upgrade.

IP Configuration

If the DM-TX-100/-F is used in a standalone configuration (not connected to a DM switcher), use Crestron Toolbox to create the IP table of the DM-TX-100/-F:

NOTE: If the DM-TX-100/-F connects is connected to a DM switcher, the IP table entry of the DM-TX-100/-F is created automatically.

- Use the Device Discovery Tool to find the IP address of the DM-TX-100/-F. Then, in the Toolbox, display the "System Info" window (click the icon) and select the DM-TX-100/-F entry from the Address Book.
- 2. Select Functions | IP Table Setup.
- 3. Add, modify or delete entries in the IP table. The DM-TX-100/-F can have only one IP table entry.
- 4. A defined IP table can be saved to a file or sent to the device.

Problem Solving

Troubleshooting

The following table provides corrective action for possible trouble situations. If further assistance is required, please contact a Crestron customer service representative.

Device does not function.	Device is not communicating with the network.	Use Crestron Toolbox to poll the network. Verify network connection to the device.

	Device is not receiving sufficient power.	Use the DMNet Power Calculator to help calculate how much power is needed for the system.
PWR LED does not illuminate.	Device is not receiving power.	Verify PWR connections are properly attached.
DM LINK LED does not illuminate.	Device is not transmitting DMNet signal.	Verify DM OUT connections are properly attached.
Loss of functionality due to electrostatic discharge.	Improper grounding.	Check that all ground connections have been made properly.

Check Network Wiring

Use the Right Wire

To ensure optimum performance over the full range of your installation topology, use Crestron Certified Wire only. Failure to do so may incur additional charges if support is required to identify performance deficiencies because of using improper wire.

Calculate Power

CAUTION: Use only Crestron power supplies for Crestron equipment. Failure to do so could cause equipment damage or void the Crestron warranty.

CAUTION: Provide sufficient power to the system. Insufficient power can lead to unpredictable results or damage to the equipment. The **EIG** connector on the DM switcher is used to bring in external power. Additional power is rarely required as switchers provide enough power for most typical configurations. Please use the DMNet Power Calculator to help calculate how much power is needed for the system (www.crestron.com/calculators).

NOTE: All Crestron certified DMNet wiring must consist of two twisted pairs. One twisted pair is the +24V conductor and the GND conductor and the other twisted pair is the A conductor and the B conductor.

NOTE: 1080p60 is the most common resolution used in residential installations.
