Description

The PWI-1215 is capable of powering a 12 volt Crestron® product from a standard ac outlet (220-240 Vac, 50 Hz). It is designed for indoor use only.

CAUTION: Connect this power pack only to a Crestron device that is rated at 12 volts and no more than 1,500 milliamps. Plugging this power pack into a Crestron device that has a different rating could damage the device or the power pack.

Crestron suggests that only this power pack be used with designated Crestron products. In the event another compatible power pack (not supplied by Crestron) is required, the specifications are listed in the following table.





Setup

Refer to the illustration below and connect the power pack.

- Insert the PWI-1215 plug into the dc power socket connector of a Crestron device.
- Attach the appropriate line cord (not supplied) to the PWI-1215 line cord connector.
- Insert the wall connector end of the line cord into an active ac outlet.

Merchandise Returns / Repair Service

Authorized returns must be shipped freight prepaid to Crestron, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. Crestron reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- Return freight charges following repair of items under warranty shall be paid by Crestron, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

Crestron Limited Warranty

Crestron Electronics, Inc. warrants its products to be free from manufacturing defects in materials and workmanship under normal use for a period of three (3) years from the date of purchase from Crestron, with the following exceptions: disk drives and any other moving or rotating mechanical parts, pan/tilt heads and power supplies are covered for a period of one (1) year; touch screen display and overlay components are covered for 90 days; batteries and incandescent lamps are not covered.

This warranty extends to products purchased directly from Crestron or an authorized Crestron dealer. Purchasers should inquire of the dealer regarding the nature and extent of the dealer's warranty, if any.
